

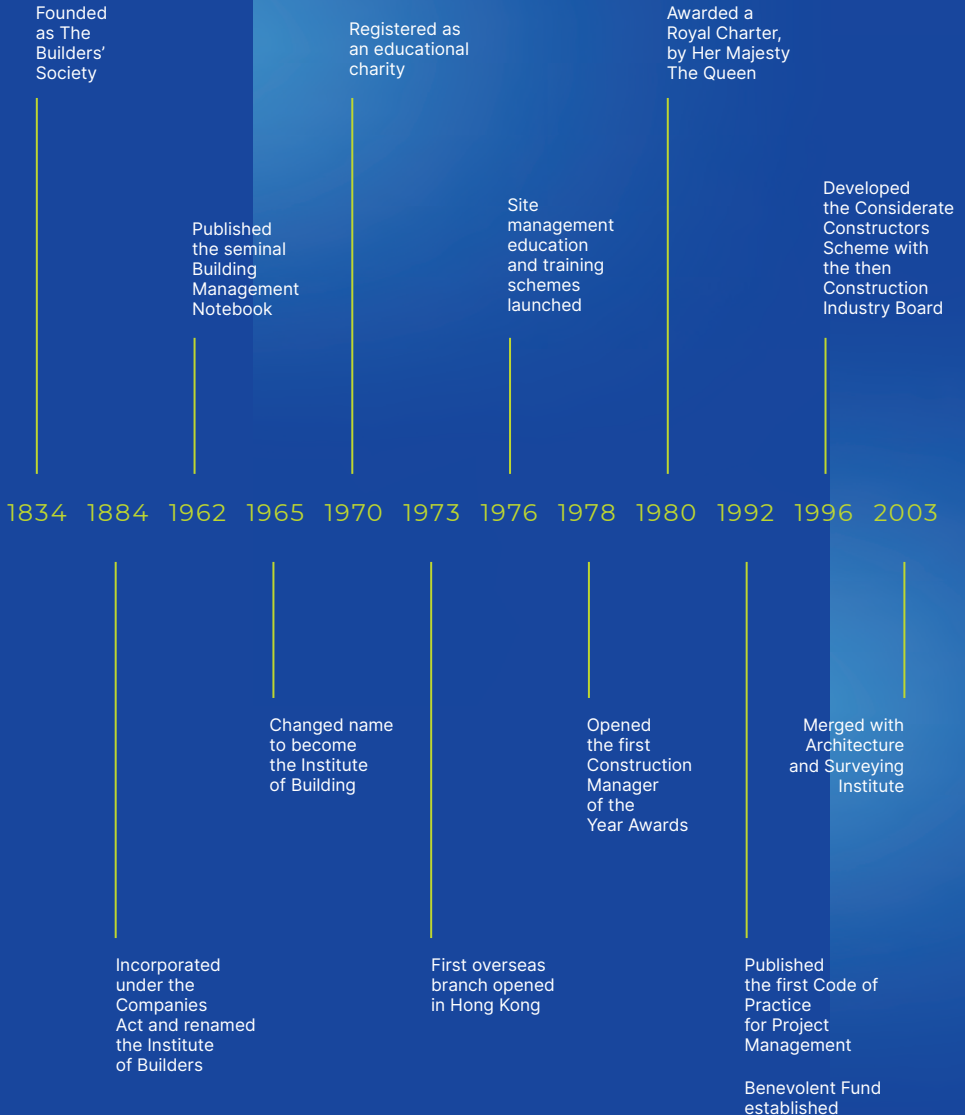


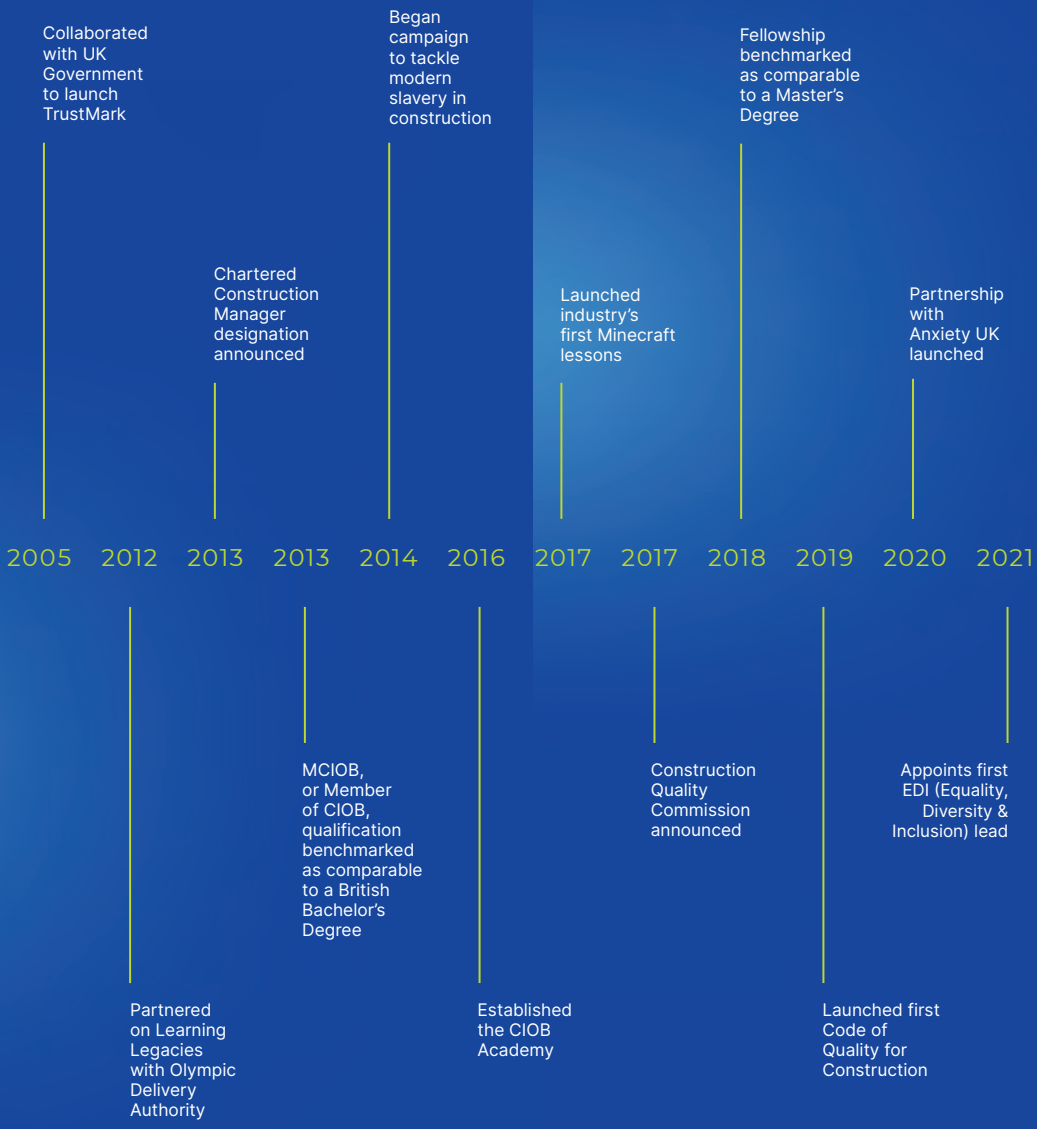

# Working with employers

We work with employers of all sizes, all over the world. These close connections with companies and consultancies help us support every part of our industry's workforce.

There are 1,000 construction organisations who work with us to improve the standard of construction and to increase the opportunity for management careers. There are two main initiatives for employers to work with us.

The first is our Chartered Building Company and Consultancy Scheme, or CBCs for short. Just as individuals work towards Chartered Membership, so can an entire organisation achieve Chartered status with us. This gives them a competitive advantage by helping businesses become a trusted resource for clients.

To become a CBC a business must have been trading for two or more years and at least half of the Executive Board must be Chartered with a built environment professional body, with a minimum of 25% Chartered with CIOB.

The second is in becoming a Training Partnership. This is a free service that CIOB offers to construction businesses in the built environment. Through a joint venture we create a bespoke training, learning and development plan for their staff, paving the way towards a fully Chartered workforce.

Primarily our Training Partnerships support those in junior management roles and upwards, regardless of age, experiences or qualifications.





# Collaborating with partners

We collaborate with all kinds of organisations across the world, so we can give our members the best support no matter what they need.

We were the first professional body to join Build UK, which provides a collective voice for the construction industry supply chain. And we're a part of the Construction Industry Council – the representative forum for professional bodies, research organisations and specialist business associations.

To bridge the link between industry and academia, we work with many education and research organisations. And we work closely with other professional bodies on related issues, campaigns and in enabling greater access to the professions across the globe.



# Creating the experts for the future

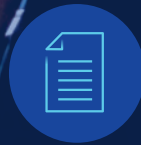

# How we are governed

Because we are governed by a Royal Charter, and registered as a charity in England, Wales and Scotland, we are bound to operate in a way that is transparent and inclusive.

Our Board of Trustees, made up of Fellows and Chartered Members, ensure we work in accordance with our Royal Charter objectives and that we have a strategic plan in place for the future development of CIOB.

Trustees, who volunteer their time, are supported by various governance committees and CIOB Leadership Team. We also have a Members' Forum which we use as a consultative body; this Forum brings together leading construction professionals from across the globe to represent the interests of all members.

All of this means that our members safeguard the present and lead the future direction of CIOB.





# How we influence beyond our Institute

We work on a great variety of agendas. They're not always just in the interest of our members – but they are always in the interest of the public. Our job is to advance knowledge, innovation and research – and that means challenging our industry to be the best it can possibly be.

We also promote the impact and importance construction has on the people who use the built environment, and the economies that support it.

We influence government and other stakeholders by offering an informed and unbiased opinion. We do this through CIOB research, through our members' expert advice and in consultation with other professions and other organisations.

We are proud to say we have a long history of helping and engaging policy makers on construction issues. The campaigns we are working on now include tackling modern slavery in construction, improving the quality of buildings and the broader built environment, and ensuring both the health and safety of construction workers is paramount.

Within UK Government we chair, steer and input on many All-Party Parliamentary Groups. With other professional bodies, we can be found at Party Conferences hosting roundtables and taking the voice of the construction professional into debate. Some of our members are even MPs themselves and we work in collaboration with them on industry agendas.

Our credibility is such that we are regularly invited to advise government departments, committees, political groups and other stakeholders on a multitude of issues. We provide consultation and written evidence to government as we respond to proposed legislative changes.
