What is the Building Conservation Certification Scheme?

The scheme provides recognition for those who work on traditional and historic buildings in many areas. This includes clients, consultants, academics, regulators and contractors. It is aimed at recognising an individual's competence in their professional role within Building Conservation.

The scheme comprises a register of individuals that recognises competence at three levels:

1. **Registered** – members at this level can demonstrate good working and background knowledge of key aspects of work to traditional buildings and conservation practice, principles and philosophy, and understand when guidance or supervision is required.
2. **Proficient** - members at this level can demonstrate a depth of understanding of conservation practice, principles and philosophy, including significance, and to guide and take responsibility for others whilst understanding when further specialist guidance is required.
3. **Certified** – members at this highest level can demonstrate authoritative knowledge of conservation practice, principles and philosophy, including significance, and contribute to the development of conservation standards.

Members of the scheme can progress through the levels by acquiring additional qualifications and experience and making an application providing their role makes this possible.

The scheme is based on the ICOMOS (International Council on Monuments and Sites) training and education guidelines, and individuals will be asked to demonstrate their competence against these standards. In addition, the CIOB Scheme requires a demonstration of competence regarding sustainability and energy efficiency issues. Eligibility

All applicants must have sufficient, relevant and responsible practical experience to demonstrate competence in building conservation and working on traditional buildings and structures.

- Registered – 'CIOB Registered in Building Conservation'
- Proficient - 'CIOB Proficient in Building Conservation'
- Certified - 'CIOB Certified Building Conservation Specialist'
